1 In California, children less than 57" must be in the rear seat, if available. Children weighing more than 40 lbs. may be belted without a booster seat if they are seated in the rear seat of a vehicle not equipped with lap/shoulder belts. A child may not ride in the front seat of a motor vehicle with an active passenger airbag if the child is riding in a rear-facing child restraint system.

2 In Colorado, vehicles without lap/shoulder belts are exempt.

3 In Connecticut, vehicles without lap/shoulder belts are exempt.

4 In Delaware, no child who is 65" or less in height or is under 12 years of age shall occupy the front passenger seat of any vehicle equipped with a passenger-side airbag that has not been deliberately rendered inoperable.

5 In Florida, a seat belt may be used for children ages 4 to 6 when the child is either being transported by someone who is not a member of the child's immediate family, in an emergency, or has a documented medical condition that necessitates an exception.

6 In Hawaii, children under 8, but at least 4'9" are not required to use a child restraint. Vehicles without lap & shoulder belts are exempt as long as the child is seated in the rear seat.

7 In Illinois, a child weighing more than 40 lbs. may be transported in the back seat of a motor vehicle while wearing only a lap belt if the back seat of the motor vehicle is not equipped with a combination lap and shoulder belt.

8 In Indiana, a child weighing more than 40 pounds may be transported using a lap belt if the vehicle is not equipped with lap and shoulder belts or if all lap and shoulder belts other than those in the front seat are being used to restrain other children younger than 16.

14 In New York, children under 7 but at least 4'9" and/or more than 100 lbs. are not required to be in a child restraint. Vehicles without lap/shoulder belts are exempt.

15 In North Carolina, children must be restrained in a child safety seat in the rear seat if the vehicle has a passenger airbag, unless the child restraint system is designed for use with airbags. Additionally, if all seating positions with a lap and shoulder belt are taken, children less than 8 and between 40 and 80 lbs. may be seated in a properly positioned lap belt.

16 In North Dakota, vehicles without lap/shoulder belts are exempt.

17 In Oklahoma, a child weighing more than 40 lbs. may be transported in the back seat of a motor vehicle while wearing only a lap belt if the back seat of the motor vehicle is not equipped with a combination lap and shoulder belt.

*All child restraint laws are primary; however, Ohio's is secondary, and Nebraska's law is secondary for those who may be in safety belts and standard for those in a child restraint device.

20 In Vermont, children under 2 or less than 20 pounds must be in the rear seat unless the front passenger airbag is deactivated.

21 In Virginia, children 4-7 years-old may use an adult belt only with a doctor's exemption for a medical reason.

22 In Washington, children at least 4'9" are not required to use a child restraint. Children under 13 must be in the rear seat.

23 In West Virginia, children at least 4'9" are not required to use a child restraint.

24 In Wisconsin, children under 4 yrs. must be in rear seat, if available.

25 In Wyoming, children may sit in the front seat if all rear seats are occupied. Children under 9 who properly fit in a seat belt do not need to use a child restraint.
